## ASSUMPTION OF RISK

I am aware that participation in the sport of netball has inherent risks, including, but not limited to:

- any manner of injury resulting from the use, misuse, non-use, or failure, of any equipment;
- all manner of injury from tripping, falling, impacting with the floor, court, balls, or equipment, and collision, or coming into contact, with other players, coaches, officials or spectators;
- theft, vandalism, or loss, of personal property;
- all manner of injury from use and occupation of the sports facilities and locations at which netball events and training sessions are held; and
- inability or delay in accessing first aid or medical assistance in the event of an accident.

I freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage or loss, resulting therefrom.

## RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT:

In consideration of the Netball Alberta allowing my participation in the sport of Netball, and the activities and events of the Netball Alberta, I agree as follows:

- 1) TO WAIVE ANY AND ALL CLAIMS that I have or may have in the future against the Netball Alberta, Southland Leisure Centre, Calgary Board of Education, City of Calgary, and any other owner or occupier of sport facilities or locations at which netball events or training sessions are held, and their respective members, directors, employees, servants, agents, volunteers, and independent contractors (all of whom are hereinafter collectively referred to as "the Releasees");
- 2) TO RELEASE THE RELEASEES from any and all liability for any loss, damage, injury, or expense that I may suffer, or that my heirs, survivors, or next of kin, may suffer, as a result of my participation in the sport of netball, or in the activities or events of the Netball Alberta, due to any cause whatsoever including NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE UNDER THE OCCUPIER'S LIABILITY ACT, RSA 2000 c. 0-4 (as amended from time to time) ON THE PART OF THE RELEASEES;

- 4) TO INDEMNIFY AND SAVE HARMLESS THE RELEASEES from, and to accept sole responsibility for, any loss, damage, injury or expense howsoever caused or suffered by any child, or other person for whom I am in law responsible, who accompanies me to, or is otherwise present at, any netball event, training session, activity or event of Netball Alberta.
